Notice of Voter Registration Deadlines

All voter registration applications, transfers from another county, and changes of address within Chelan County, submitted by mail or online, must be postmarked by Monday, October 6, 2014 or may be delivered to the Chelan County Auditor's Office no later than 5:00 p.m., Monday, October 6, 2014 to be eligible for the November 4, 2014 General Election.

Persons not already registered in Washington State may register in-person no later than Monday, October 27, 2014 at the Chelan County Auditor's Office, 350 Orondo Ave Level 3, Wenatchee, Monday thru Friday, 9:00 a.m. – 5:00 p.m.

Notice of November 4, 2014 General Election
