- AUTHORITY:** Revised Code of Washington (RCW) 29A.08.810 - 850
- WHEN:** August 9th, 2011 at 2:00PM
- WHERE:** Chelan County Elections Office

- PRESIDING:** Chelan County Canvassing Board of Elections consisting of the Chair, Chelan County Commissioners, County Prosecuting Attorney, the Auditor and Elections Department or their official designees.
- CHALLENGER:** *Charles Slowe*
- CHALLENGED:** *Vicki Griffin*
- NATURE OF CHALLENGE:** That the challenged voter does not reside at the address at which presently registered.
- CONDITIONS:** If the challenged voter considers the challenge to be correct and resolves the matter by filing with this office either a change of address request or a cancellation of her Chelan County voter registration, prior to the hearing date, the hearing will be cancelled and matter considered resolved.
- The burden of proof in a challenge is on the challenger.
- ATTENDANCE:** Attendance of the challenger and the challenged voter is requested.
- If unable to attend, an affidavit under oath stating the reasons why the individual believes the challenge to be valid or invalid, as appropriate, along with any documentation, may be submitted in lieu of attending.
- If either party or both parties fail to attend or to file an affidavit, the Canvassing Board shall make its determination based on the available facts.
