- Select one political party preference below. If you do not select a party preference or if you select more than one party, your votes for partisan candidates will not count.
- Vote for candidates from the political party you selected. Votes for another party's candidates will not count.
- Vote for nonpartisan offices and ballot measures. "Nonpartisan" means, as the context implies, judicial offices, other offices without a party label, or ballot issues. These races and measures will be found on the back of your ballot. These votes will be counted, even if you do not mark a political party.
