Referendum Measure No. 71

The legislature passed Engrossed Second Substitute Senate Bill 5688 concerning rights and responsibilities of state-registered domestic partners and voters have filed a sufficient referendum petition on this bill. This bill would expand the rights, responsibilities, and obligations accorded state-registered same-sex and senior domestic partners to be equivalent to those of married spouses, except that a domestic partnership is not a marriage.

Wenatchee Fire Facilities
Bonds - \$11,745,000

The City Council of the City of Wenatchee passed Ordinance No. 2009-22 concerning financing construction of a new fire headquarters and related improvements. If approved, this proposition would authorize the City to issue not more than \$11,745,000 of general obligation bonds (maturing within 20 years or less) to acquire land and construct a new headquarter fire station and training site, including furniture, fixtures and equipment, and levy property taxes annually in addition to regular tax levies to repay such bonds, all as provided in the ordinance.
