RESOLUTION 13-01

WHEREAS, the funds available for Kahlotus School District No. 056 through presently scheduled sources are insufficient to meet the needs of the District, and

WHEREAS, school districts are authorized special levies by a vote of the resident electors of the District, and

WHEREAS, the necessary funds are not available through any other known source;

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Directors of the Kahlotus School District No. 056, Franklin County, Washington, that a special school election be held in the aforesaid school district on the 11th day of February, 2014, for the purpose of submitting to the electors of said school district for their approval or rejection the following proposition:

"Shall Kahlotus School District No. 056, Franklin County, Washington, authorize the County Commissioners of Franklin County to levy a tax of \$75,000, to be collected in 2015 requiring approximately \$1.62 per \$1,000 of assessed valuation, and again in 2016 for \$75,000, requiring approximately \$1.59 per \$1,000 of assessed valuation, to be used in the General Fund and for maintenance and operations?"

The Business Manager of the aforesaid school district is hereby directed to immediately transmit to the Franklin County Auditor a copy of this resolution, duly signed and attested by which the Franklin County Auditor is hereby required to take all procedural steps necessary and/or required by law to the end that this proposition shall be submitted to the voters of said school district.

The foregoing resolution was adopted at a regular meeting of the Board of Directors of the aforesaid school district on the 17th day of December, 2013, the undersigned directors being present and voting.
