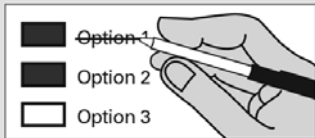

Advisory Vote of the People

Advisory Vote No. 16  
Engrossed Substitute House Bill 1597

The legislature increased, without a vote of the people, the food fish excise tax rate on certain salmon and game fish, costing less than \$1,000,000 in the first ten years, for government spending.

Engrossed House Bill 2163

Advisory Vote No. 18  
Engrossed House Bill 2242

Proposition No. 1

The McCleary City Council adopted Ordinance No. 833 concerning a levy lid lift to allow the Fire Department to replace expired and non-compliant equipment. To fund such action, this proposition would increase the City's current regular property tax levy of \$2.81 per \$1,000 by \$0.48 to the authorized rate of \$3.29 per \$1,000 of assessed valuation for collection beginning 2018 and use the 2018 levy amount to calculate 2019, 2020, 2021 and 2022 collection years.
