

The number of votes necessary to validate the proposition being 3557 based on 40% of the 8891 votes cast in said district at the preceding General Election held on November 3, 1998.

The North Whidbey Park & Recreation District Proposition received a 54.82% vote in favor of the proposition. Proposition failed.
