The undersigned officers designated by law as constituting the Canvassing Board for the County of Island, State of Washington, hereby certify that this is a full, true and correct copy of the Abstract of Votes cast at the Island County Special Election, held on February 3, 2004, in Island County, State of Washington; that the total number of votes cast in said election was *5,066*.

The number of votes necessary to validate the propositions being 2108 based on 40% of the 5269 votes cast in said district at the preceding General Election held on November 4, 2003.

The South Whidbey School M & O levy received a *71%* vote in favor of the proposition. The South Whidbey School Capital levy received a *74%* vote in favor of the proposition. The South Whidbey Park & Recreation District 4 year M & O levy received a *70%* vote in favor of the proposition. The propositions required 60% in favor. The propositions passed.
