NOTICE IS HEREBY GIVEN to the qualified voters of Jefferson County, State of Washington that on Tuesday, February 10, 2015, a Special Election will be conducted entirely by mail.

Jurisdictions / Measures in this election:

Local Measures

- City of Port Townsend, Proposition No. 1 – Mountain View Commons Improvement Bonds
- Sequim School District No. 323, Proposition No. 1 – School Improvements General Obligation Bonds
- Port Townsend School District No. 50, Proposition No. 1 – Replacement Educational Programs and Operations Levy
- Chimacum School District No. 49, Proposition No. 1 – Facility Improvement General Obligation Bonds

Ballots for this election will be mailed to all qualified voters on January 21, 2015.

Voter Registration Deadlines for persons registering to vote in Washington State for this election are:

Jan. 12, 2015 Twenty-nine days before the election – Last day for mail or online new registrations and voter updates within and between Washington counties.

Feb. 2, 2015 Eight days before the election – Last day for in-person registration at the Jefferson County Auditor's Office (1820 Jefferson St., Port Townsend) for those voters not already registered in the State of Washington.

Voter registration forms are available at the Jefferson County Auditor's Office as well as various locations throughout the county (schools, libraries, community centers, etc). You may also register to vote and change your name and address at all driver licensing locations or online at www.myvote.wa.gov.

A registered voter who misses the deadline to transfer his or her residential address may vote according to his or her previous registration address. Registration applications and updates submitted after the deadline will take effect for the next election.

Any voter who does not receive their ballot, or needs a replacement ballot, may request one:

- **Online** at www.myvote.wa.gov, (enter your name as you are registered, and your date of birth);
- **By phone** to the Jefferson County Auditor's Office: 360-385-9119 or;
- **In person** at the Auditor's Office (1820 Jefferson St., Port Townsend).

Contact the Jefferson County Auditor's Office for additional information about voter registration or the Special Election.

An Accessible Voting Unit (AVU) is available at the Jefferson County Auditor's Office from 8:30 a.m. – 4:30 p.m. weekdays, Jan. 21, 2015 thru Election Day, February 10, 2015, with Election Day hours from 8:30 a.m. to 8:00 p.m. The AVU is equipped with audio and visual technology allowing voters to vote a secret ballot independently. The side entrance to the County Courthouse, located on Cass St., is handicapped accessible.

How to return your ballot:

- **By Mail:** First Class Postage is required on all ballots returned by mail. If you are mailing your ballot on Election Day, be sure to check the postmark cut off time at your Post Office. Ballots bearing a postmark after February 10, 2015 will be considered late, and cannot be counted.
- **Drop Box:** Two Drop Boxes are available 20 days before an election and open 24 hours a day. On Election Day, ballots will be accepted in the drop boxes until 8:00 p.m.
 - Jefferson County Courthouse: 1820 Jefferson St., Port Townsend - back parking lot.
 - Jefferson County Rural Library: 620 Cedar Ave., Port Hadlock – next to book drop in parking area.
- **In-Person:** Auditor's Office on the 1st Floor in the Jefferson County Courthouse, 1820 Jefferson St., Port Townsend. Regular office hours Monday - Friday 8:30 a.m. – 4:30 p.m. with Election Day hours 8:30 a.m. – 8:00 p.m.

In order for a ballot to be counted, the voter must sign the Voter's Declaration on the return envelope.

Open Public Meetings:

The Jefferson County Canvassing Board, or their appointed designees, pursuant to RCW 29A.60.160, will hold open public meetings under the applicable provisions of chapter 42.30 RCW on the dates and times listed below. Each meeting shall be continued until the activity for which the meeting is held has been completed.

All ballot processing activities will be held in the Jefferson County Auditor's Office on the 1st Floor of the County Courthouse. Unless otherwise noted, activities will be performed between 8:30 a.m. – 4:30 p.m.
