

**Hospital District No. 2
Proposition 1
Levy Lid Lift**

The Commission has adopted Resolution No. 459 concerning an increase in the District's regular property tax levy.

If approved, this proposition would provide funding for the operation, development and expansion of the District's health care facilities and services including the funding of an electronic medical records system. It authorizes a maximum regular property levy rate in 2012 of \$0.35/\$1,000 assessed value (which is \$0.07 greater than the 2011 levy rate). The 2012 levy amount will be used to calculate subsequent levy limits in subsequent years.

PROSSER CONSOLIDATED SCHOOL DISTRICT NO. 116-219

BONDS FOR CONSTRUCTION OF A NEW HIGH SCHOOL

The Board of Directors of Prosser Consolidated School District No. 116-219 adopted Resolution No. 01-11 concerning a proposition to finance construction of a new high school. This proposition would authorize the District to construct and equip a new high school on a site owned by the District adjacent to Art Fiker Stadium to replace Prosser High School; issue no more than \$38,950,000 of general obligation bonds maturing within 20 years; and levy annual excess property taxes to repay the bonds, all as provided in Resolution No. 01-11. 

GOLDENDALE SCHOOL DISTRICT NO. 404

GENERAL OBLIGATION BONDS - \$32,000,000

The Board of Directors of Goldendale School District No. 404 adopted Resolution #10-11-04 concerning this proposition for bonds. The proposition authorizes the District to construct a new high school to replace and/or renovate Goldendale High School, renovate Goldendale Middle School, and make certain capital improvements to other facilities of the District to issue \$32,000,000 of general obligation bonds maturing within a maximum of 20 years; and collect excess property taxes annually to repay the bonds, as provided in Resolution #10-11-04.
