On July 15, 2016, the Auditor will mail each qualified voter within the county a mail ballot. First class postage is required for returning a voted ballot by mail and must be postmarked by August 2, 2016. Ballots must be returned to our office or dropped into a designated drop box by 8:00 P.M. on August 2, 2016. Replacement ballots may be obtained in the Auditor's Office or by visiting the MyVote website: [myvote.wa.gov](http://myvote.wa.gov).

An Accessible Voting Unit is available in the Auditor's Office beginning July 15, 2016 through August 1, 2016 from 8:30 A.M. to 5:00 P.M. with extended hours on August 2, 2016 from 8:30 A.M. to 8:00 P.M. Special accommodations will be made upon request.

The Logic and Accuracy Test will be held June 29, 2016. The public is invited to observe this test at 2:00 P.M. in the Auditor's Office.

The canvassing board, pursuant to 29A.60 RCW, will hold a public meeting at 8:30 A.M., August 9, 2016 to examine returns and adopt revisions to the canvassing board manual and at 8:30 A.M., August 15, 2016 in the Auditor's Office to certify the cumulative results, precinct results and a reconciliation report of the votes cast.
