
How to vote

**Hospital District # 2**  
**Proposition No. 1**  
**Levy Lid Lift**

The Commission of Public Hospital District No. 2, Klickitat County, adopted Resolution No. 507 concerning a renewal of the District's regular property tax levy. If approved, this proposition would provide funding for the operation, development and expansion of the District's health care facilities and services. It authorizes a maximum regular property levy rate for collection in 2017 of \$0.34/\$1,000 assessed value (which is equal to the rate levied in 2016). The 2017 levy amount will be used to calculate levy limits in subsequent years for a period of twenty years. Should this proposition be:
