





Replacement of Expiring Educational Programs, Maintenance and Operational Levy

The Board of Directors of Centerville School District No. 215 adopted Resolution No. 2015-06 concerning a proposition for a replacement levy for educational needs. This proposition would authorize the District to meet the educational needs of students by levying the following excess taxes, in place of the expiring levy, on all taxable property within the District, for support of the District's General Fund educational programs, maintenance and operation expenses, and curriculum purchases.

Replacement Maintenance & Operation Levy

The Board of Directors of Glenwood School District No. 401 adopted Resolution No. 169, concerning a proposition to finance school programs and maintenance and operation expenses. This proposition would authorize the District to levy the following excess taxes, in place of an expiring levy, on all taxable property within the District, for support of the District's General Fund educational maintenance and operation expenses:

GOLDENDALE SCHOOL DISTRICT # 404
Proposition No. 1

General Obligation Bonds - \$9,200,000

The Board of Directors of Goldendale School District No. 404 adopted Resolution No. 15-16-03 concerning this proposition for bonds. The proposition authorizes the District to renovate Goldendale High School, with upgrades to include internet, technology, heating, cooling, electrical wiring, alarm and sprinkler systems; make technology upgrades to Goldendale Middle and Primary Schools, and make certain capital improvements to other facilities of the District; to issue \$9,200,000 of general obligation bonds maturing within a maximum of 20 years; and collect excess property taxes annually to repay the bonds, as provided in Resolution No. 15-16-03.
