

Single Year Temporary Levy
Lid Lift for Five Years
The City of White Salmon City Council adopted Ordinance No. 2012-07-896 concerning property taxes for pool operations and maintenance. If approved this proposition would authorize the City to set its 2013 regular property tax levy rate at \$1.362 per \$1,000 (an increase of \$0.18 per \$1,000 over the current levy) to finance pool operations and maintenance. 

Port District # 1 - Proposition 1
Regular Property Tax Levy Lid Lift
The Port Commission adopted Resolution 5-2012 proposing an increase in the District's regular property tax levy. If approved, this proposition would provide funding for all District operations and capital improvements authorized under Revised Code of Washington Title 53. It authorizes a maximum regular property tax levy rate in 2013 of \$0.505 per \$1,000 of assessed value and use of the 2013 levy amount to calculate the levy limit in subsequent years.
