First class postage is required for returning a voted ballot by mail and must be postmarked by August 7, 2012. Ballots must be returned to our office or dropped into a designated drop box by 8:00 P.M. on August 7, 2012. An Accessible Voting Unit is available in the Auditor's Office beginning July 18, 2012 through August 6, 2012 from 9:00 A.M. to 5:00 P.M. with extended hours on August 7, 2012 from 9:00 A.M. to 8:00 P.M. Special accommodations will be made upon request.

The Logic and Accuracy Test will be held June 28, 2012. The public is invited to observe this test at 9:30 A.M. in the Auditor's Office.

The canvassing board, pursuant to 29A.60 RCW, will hold a public meeting at 9:00 A.M., August 14, 2012 to examine returns and at 9:15 A.M., August 21, 2012 in the Auditor's Office to certify the cumulative results, precinct results and a reconciliation report of the votes cast.
