Notice is hereby given that a Special Election will be held in Klickitat County, Washington, February 12, 2013, in the following districts within Klickitat County: Fire District # 14, Trout Lake School District # 400, Klickitat School District # 402, and Lyle School District # 406. The election will be conducted by mail ballot.

The last day to register to vote online, through the mail, transfer or update an existing registration is January 14, 2013. The last day to register to vote *in person* is February 4, 2013, in the Klickitat County Auditor's Office, 205 S. Columbus Ave. Room 203, Goldendale, WA. The registration books will remain closed until February 26, 2013.

Klickitat School District # 402, Maintenance and Operation Levy

On or before January 25, 2013, the Auditor will mail each qualified voter within the county a mail ballot. First class postage is required for returning a voted ballot by mail and must be postmarked by February 12, 2013. Ballots must be returned to our office or dropped into a designated drop box by 8:00 P.M. on February 12, 2013. Replacement ballots may be obtained in the Auditor's Office or by visiting www.myvote.wa.gov.

An Accessible Voting Unit is available in the Auditor's Office beginning January 25, 2013, through February 11, 2013, from 8:30 A.M. to 5:00 P.M. with extended hours on February 12, 2013, from 8:30 A.M. to 8:00 P.M. Special accommodations will be made upon request.

The Logic and Accuracy Test will be held January 14, 2013. The public is invited to observe this test at 10:00 A.M. in the Auditor's Office.

The canvassing board, pursuant to 29A.60 RCW, will hold a public meeting at 9:00 A.M., February 19, 2013, to examine returns and at 9:00 A.M., February 26, 2013, in the Auditor's Office to certify the cumulative results, precinct results and a reconciliation report of the votes cast.
