



FORT VANCOUVER REGIONAL LIBRARY DISTRICT PROPOSITION #1 AUTHORIZING PROPERTY TAX LEVY

The Fort Vancouver Regional Library District Board of Trustees adopted resolution 2010-5 concerning a proposition to authorize its regular property tax levy. This proposition would authorize the District to restore its regular property tax levy to the allowable rate of \$0.50 per \$1,000 of assessed value for collection in 2011 to provide continued funding for the Fort Vancouver Regional Library District's normal operation and maintenance. Thereafter, such levy amount would be used for the purpose of computing limitations for subsequent levies as allowed by RCW 84.55.
