Notice is hereby given that a Special Election will be held in Klickitat County, Washington, February 9, 2016, in the following districts within Klickitat County: Centerville School District # 215, Glenwood School District # 401, Klickitat School District # 402, and Goldendale School District # 404. The election will be conducted by mail ballot.

The last day to register to vote online, through the mail, transfer or update an existing registration is January 11, 2016. The last day to register to vote *in person* is February 1, 2016, in the Klickitat County Auditor's Office, 205 S. Columbus Ave. Room 203, Goldendale, WA. The registration books will remain closed until February 19, 2016.

On or before January 22, 2016, the Auditor will mail each qualified voter within the county a mail ballot. First class postage is required for returning a voted ballot by mail and must be postmarked by February 9, 2016. Ballots must be returned to our office or dropped into a designated drop box by 8:00 P.M. on February 9, 2016. Replacement ballots may be obtained in the Auditor's Office or by visiting myvote.wa.gov.

An Accessible Voting Unit is available in the Auditor's Office beginning January 22, 2016, through February 8, 2016, from 8:30 A.M. to 5:00 P.M. with extended hours on February 9, 2016, from 8:30 A.M. to 8:00 P.M. Special accommodations will be made upon request.

The Logic and Accuracy Test will be held January 6, 2016. The public is invited to observe this test at 2:00 P.M. in the Auditor's Office.

The canvassing board, pursuant to RCW 29A.60, will hold a public meeting at 9:15 A.M., February 16, 2016, to examine returns and at 9:15 A.M., February 19, 2016, in the Auditor's Office to certify the cumulative results, precinct results and a reconciliation report of the votes cast.
