You may obtain a replacement ballot if the original ballot is destroyed, spoiled or lost; call (360) 875-9317. Replacement ballots may be requested in person at the South Bend Auditor's office. The Auditor's offices are ADA compliant, voting aids are available upon request.

Ballots may be returned by mail, place a 44 cent stamp on the ballot return envelope. **YOUR BALLOT MUST BE POSTMARKED NO LATER THAN THE DAY OF THE ELECTION.**


Vote for one choice for each office or ballot measure. If you vote for more than one choice for that office or ballot measure, no votes will be counted for that contest or ballot measure.
