NOTICE IS HEREBY GIVEN, that on Tuesday, May 24, 2016, in Skamania County, State of Washington, there will be held a State Presidential Primary for the purpose of allowing voters to indicate their preference for nominating candidates for President of the United States, to be voted for at the General Election to be held Tuesday, November 8, 2016.

Voter registration deadlines:

The deadline for initial mail-in or online registrations and transfers or updates to an existing registration is 5 pm, Monday, April 25, 2016.

If you are **not** registered in Washington State by April 25, you may still register, but you must do so **in person** in the Elections Office by 5 p.m., Monday, May 16, 2016.

Meeting Notice


