**REPLACEMENT MAINTENANCE AND OPERATION LEVY
ROSALIA SCHOOL DISTRICT NO. 320
RESOLUTION NO. 2015-07**


WHEREAS, there are insufficient funds available to the Rosalia School District No. 320 of Whitman County, State of Washington, to pay costs of maintaining the educational program of the District for the 2016-17 and the 2017-18 school years and additional funds are needed to prevent the impairment of the District's obligations, and,


WHEREAS, an emergency now exists for the funds to provide for the foregoing purpose,

NOW, THEREFORE, BE IT RESOLVED that the Rosalia School District No. 320 of Whitman County, State of Washington, places a proposition before the electors of said District, to levy an excess tax at the estimated dollar rate of \$3.24 per \$1,000 of assessed valuation to raise exactly five hundred ninety five thousand dollars (\$595,000.00) for 2016-17 and \$3.20 per \$1,000 of assessed valuation for 2017-18 to raise exactly five hundred ninety five thousand dollars (\$595,000.00) to be placed in the General Fund of said district to help defray the costs of maintaining the educational program of the district for both the 2016-17 and 2017-18 school years.

BE IT THEREFORE RESOLVED, that the matter of making said excess taxes for the foregoing purpose be submitted to their approval and adoption, or rejection, at a Special Election to be held on the 9th day of February 2016, and the Election Board of Whitman County is hereby instructed to notify the County Supervisor of Elections of this action and to request said Board and said Supervisor to call and conduct said election in the manner provided by law. The Secretary of the Board is further instructed to prepare and recommend to the Election Board and Supervisor of elections, for their approval a form of Ballot Title to be used in said election.



REPLACEMENT MAINTENANCE AND OPERATION LEVY






