
Special Levies for 2017 and 2018 Operations

WHEREAS, the anticipated revenue for 2017 and 2018 is not deemed adequate for the necessary expense of the continued operation of the Fire District, for fire protection and emergency medical services and to give the District adequate fire protection to meet the present rate standards set by the Washington Surveying and Rating Bureau; and

WHEREAS, RCW 52.16.130 and RCW 84.52.130 provide for special levies, with voter approval, to raise revenue as required beyond that allowed by the regular statutory levy; therefore be it

RESOLVED, by the Board of Commissioners of Spokane County Fire Protection District 9 that the District Secretary request the County Auditor to call a special election in the Fire District on February 9, 2016 , to submit to the qualified electors of said Fire District for their approval or rejection a request for special levies to raise \$7,100,000 in excess of the regular levy for 2017 and \$7,450,000 in excess of the regular levy for 2018, both for continued operation of fire protection and emergency medical services.



PROPOSITION NO.

SPOKANE COUNTY FIRE PROTECTION DISTRICT NO. 9 REPLACEMENT MAINTENANCE AND OPERATION LEVY

The Board of Commissioners of Spokane County Fire Protection District No. 9 adopted Resolution No. 15-7 concerning a proposition to meet the District's maintenance and operation needs. This proposition would authorize the District to levy the following taxes, in place of an existing levy, upon all taxable property within the District, for support of the District's Expense Fund expenditures for maintenance, operations and emergency medical services:


