**Proposition No. 1**  
**City of Airway Heights**  
**General Obligation Park Facilities Bonds**  
**Principal Amount of \$5,000,000**

The City Council of the City of Airway Heights adopted Ordinance No. C-594 concerning a proposition to finance capital improvements to its park and recreation facilities. This proposition will authorize the city to pay the costs of a recreation center, including an aquatics center, a fitness center and community classrooms and multi-purpose spaces; to issue not to exceed \$5,000,000 of General Obligation Bonds maturing within a maximum term of 20 years to pay for such recreation center; and levy annual excess property tax levies to pay and retire such bonds, all as provided in Ordinance No. C-594.
