

    - Visited the voter's residential address to contact persons at the address to determine if the voter actually resides there. If I was able to contact anyone who owns, manages, resides, or is employed at the address, I am submitting a signed affidavit from that person stating that, to his or her personal knowledge, the voter does not reside at the address;
    - Searched local telephone directories to determine whether the voter maintains a telephone listing at an address within the county;

Searched county auditor property records to determine whether the voter owns any property in the county; and

Searched the statewide voter registration data base to determine if the voter is registered at any other address in the state.

Mr Nesbitt, being a Fire Commissioner for the Spokane Valley Fire Dept is well aware of the residency requirements for him to hold office. When confronted with evidence/information that he lives outside of the district, Mr Nesbitt admitted in an open meeting of the SVFD fire commissioners that he lives out of district. 

Your voter registration has been challenged by Don Kresse III, based on the belief that you do not live at the address where you are registered to vote. The challenge process is established in the law RCW 29A.08.810 through RCW 29A.08.850. Voter registration records show your residential address as:

If this is incorrect, you may update your information by contacting our office at 509-477-6390.

A hearing regarding this challenge has been scheduled for Wednesday September 26 at 10:00 am at the Spokane County Elections Office 1033 W Gardner Ave Spokane WA 99201. A voter registration challenge hearing is an administrative hearing, not a court proceeding, and will be open to the public. The Spokane County Auditor will preside over the hearing.

You may provide evidence that you live at the address where you are registered, update your residential address at [www.myvote.wa.gov](http://www.myvote.wa.gov), or prove that you meet one of the exceptions allowed in law. You do not lose your residency if you are:

- absent while in government service;
- attending school;
- confined in a public prison; or
- live at a non-traditional residential address. State law allows you to list the address of a shelter, park, motor home, marina, or other identifiable location that you consider to be your residence.

You may respond by appearing at the hearing in person, or by submitting written testimony. A sample declaration is attached. If you decide to respond in writing, it must be received by our office prior to the hearing. If you do not participate in the hearing, a decision will be made based on available information and you will be contacted regarding the outcome of the hearing.
