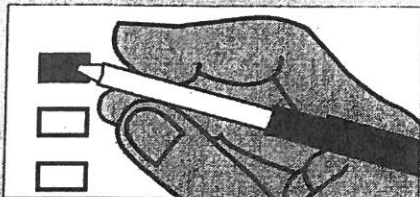

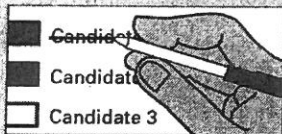
Instructions

Making selections



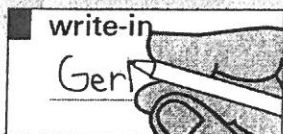
Completely fill in the box to the left of your choice. Voting more than once for a contest will be an over vote and no votes for that contest will be counted.
